# About Austin Radiology

The department is equipped with a full range of state-of-the-art imaging equipment including multi-slice CT, MRI and high-resolution ultrasound equipment. There is a wide range of interventional procedures performed, particularly in hepatobiliary and oncology intervention.

The main department is located on Levels 1 and 2 of the Lance Townsend Building, Austin Hospital. The department medical staff comprises 20 EFT of Staff Radiologists (Diagnostic, Interventional and Neurointerventional Specialists) and 19 Radiology Registrars and 4.5 Fellows.

The Austin Hospital department includes three MRI machines, two CTs, 2 Angiography suites, 1 Fluoroscopy suite and six Ultrasound units.

The Heidelberg Repatriation Hospital department provides mostly outpatient services. It consists of two CT machines, Fluoroscopy, Mammography and 5 Ultrasound rooms.

Most radiology sub-specialties, with the exception of obstetrics and paediatrics, are provided. Surgical specialties at the Austin include thoracic, cardiac, neurosurgery, hepatobiliary, orthopaedic, ENT, ophthalmology and vascular services. The Austin is a statewide referral centre for liver transplantation and spinal injuries. The hospital has a large neurology department, with particular expertise in stroke and epilepsy, and a large oncology department.

The Austin is co-located with the Mercy Hospital for Women and whilst the two hospitals have separate radiology departments, they have close ties, including the introduction of a new combined Women's Imaging fellowship in 2021. Austin Radiology provides CT, MRI and Interventional Radiology services for patients of Mercy Hospital for Women.

#### Workload

Approximately 143,000 examinations per year, comprising 83,000 CR, 9,000 MRI, 16,000 ultrasound, 22,000 CT and 6,000 interventional and fluoroscopy cases.

### Position Purpose and Accountabilities

The Radiology Department has 18 radiology registrar positions, across all levels of training from first to fifth year. A senior registrar position involves time at Austin Hospital Main Campus and the Heidelberg Repatriation Hospital Campus.

This senior registrar role has been developed for trainees who have completed their full 5 years of training at their home hospital and desire additional experience/supervision prior to embarking on subspecialty fellowship training/consultant roles. The role would require participation in the daily department workflow as directed by the weekly roster or supervising consultant. Active participation in the departmental clinical meetings, registrar teaching and quality assurance/research activities of the department are expected. As this is a senior role, there is expectation of junior staff mentorship, including teaching, supervision, and modelling of expected behaviours/work ethic.

#### **Duty requirements:**

- Full-time 43 hours per week (comprised of 9 clinical sessions and 1 academic session per week
- Participation in on-call roster requirements (evening and weekend rostered shifts)
- Maximum 3 weeks of night duty (7 days on/ 7 days off)

#### **Role Specific Skills:**

- Motivated with self-discipline
- Able to work well under pressure
- Able to make good decisions and solve problems
- Capable of accurate and careful image assessment, with an eye for detail
- Excellent at analysis and interpretation
