### **Position Purpose**

The inaugural Women's Imaging Fellowship position is a combined fellowship offered in collaboration between Austin Health and MHW. This fellowship position aims to provide a unique opportunity for the candidate to develop subspecialty skills in Women's Imaging.

This encompasses imaging skills in all facets of Gynaecology and Obstetrics, including diagnosis, staging, imaging guided treatment planning, therapeutic monitoring, clinical trial and restaging, using a variety of imaging modalities, particularly in Ultrasound, Computed Tomography and Magnetic Resonance Imaging.

Austin Health, and its associated Olivia Newton John Cancer Wellness & Research Centre and MHW, cover a wide range of tumour streams, including Colorectal and Gynae-oncology. Austin Health also prides itself on its multidisciplinary approach to cancer care, with various tumour steam multidisciplinary meetings (MDM) encompassing all oncological sub specialists such as surgical oncologists, radiation oncologists and medical oncologists as well as other relevant subspecialists such as nuclear medicine physicians, pathologists, genetics and respiratory physicians.

MHW offers a comprehensive range of services including general gynaecology, Urogynaecology, Gynae-oncology, Endosurgery, Reproductive Medicine, Perinatal Medicine and Neonatology, providing an excellent environment for learning and finessing subspecialist skills in women's imaging.

Fellows will be rostered to various modalities and time will be split between Austin (3 days a week) and MHW (2 days a week). The successful applicant will be provided academic/meeting preparation time. The fellowship will focus on Women's Imaging – with particular emphasis on O&G Ultrasound, Pelvic MRI (including fetal) and a Breast Imaging component. The fellow will be responsible for the Endometriosis, Gynae-oncology, Placenta and Colorectal MDMs. There is expected participation in the on-call and after-hours roster for Austin Health, pro-rated.

A key aspect of this position is coordination of imaging across the Austin-Mercy network, and hence strong communication skills is imperative.

Teaching of Registrars, resident staff and medical students will be required. Participation in research is strongly encouraged.

## About Radiology

Austin Health has three campuses, the Austin Campus, the Repatriation Campus and the Royal Talbot Rehabilitation Centre. Radiology services are provided by the Department of Radiology for both the Austin and Repatriation sites. Integrated RIS-PACS was installed in 2005.

The main Department of Radiology is located on Levels 1 and 2 of the Lance Townsend Building, Austin Hospital. The Department comprises 14 full-time Staff Radiologists, including 8 Interventional Radiologists, 4 Visiting Radiologists and 17 Radiology Registrars/Fellows.

The Austin Hospital Radiology department includes three MRI machines, two CT, 2 angiography suites, 1 fluroscopy suite and six ultrasound units.

The Heidelberg Repatriation Hospital Radiology Department provides mostly outpatient services. It consists of two CT machines, fluoroscopy, mammography and 3 Ultrasound rooms.

The Austin is co-located with the Mercy Hospital for Women on Studley Road, Heidelberg, and whilst the Radiology Departments are separate, they have close ties. Austin Radiology provides CT, MRI and Interventional Radiology services for patients of Mercy Hospital for Women, whilst specialist ultrasound (including tertiary-level obstetrical studies, fetal wellbeing etc) services are provided at Mercy Hospital for Women. The MHW is a 229-bed health service.

The Department of Radiology at MHW has 1EFT staff radiologist, 0.7 Sonologist EFT and 3.6 EFT Radiology Fellows/Registrars. It provides 0&G training for approximately 75% of the radiology registrars training in Victoria.

- Providing advice to staff of Austin Health and Mercy Hospital for Women about radiology procedures, protocols and radiation/MRI safety.

- Participation in departmental quality assurance projects including audits.
- Participation in departmental research projects.
- Participate in regular Radiology departmental meetings and tutorials
- Journal presentation
- Registrar Teaching
